

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.globalsciencedirective.org and Global Science Directive and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Global Science Directive include www.globalsciencedirective.org and GSD. The GSD website is a business site. By using the GSD website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with information and services offered on our Site, GSD may collect personally identifiable information, such as your:

- First and Last Name

If you donate to or request services from GSD, we collect billing and credit card information. This information is used to complete the appropriate transaction.
