

## **Terms and Conditions**

### **Agreement between User and <https://globalsciencedirective.org>**

Welcome to <https://globalsciencedirective.org>. The <https://globalsciencedirective.org> website (the "Site") is comprised of various web pages operated by Global Science Directive ("GSD"). <https://globalsciencedirective.org> is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of <https://globalsciencedirective.org> constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

<https://globalsciencedirective.org> is a Non-Profit Site.

The purpose of the Site is to provide an online profile of GSD and to showcase the scientific projects being conducted. Furthermore, the Site provides convenient options for you to make donations to fund the research being pursued and to supply the general operating costs.

### **Privacy**

### **Donations**

GSD is a legal and registered tax-exempt nonprofit as defined by IRC section 501(c)(3). The mission of GSD is to pursue projects of great scientific and societal value and received donations will be utilized in the accomplishing of this mission. We agree to provide a profile of various projects being conducted by GSD on the Site as well as pertinent legal documentation demonstrating the lawful operations of GSD. Donations are accepted and processed by a third party companies, Foxycart and Amazon. We issue end-of-calendar-year receipts to donors for each donation they make which allows donors to deduct donations from their annual taxes as allowed by IRC section 170. Finally, in effort to maintain transparency of operations, we provide quarterly newsletters to all donors outlining the activities of GSD in the previous quarter.

We post information about donors—which may include your First Initials and Last Name—on the Site, in publications, or in presentations for purposes of encouraging future donations and giving credit to the generosity of the previous donors. You may request anonymity at any time, which will be immediately honored by GSD.

By submitting the online donation, you agree to a nonrefundable donation. You also agree to the processing of this transaction by GSD and associated third parties - FoxyCart, Amazon, and relevant banking institutions. Pursuant to our Privacy Policy, GSD and these associated third parties may exchange information concerning you and your donations as it pertains to the successful transaction of funds between you and GSD.

### **Children Under Thirteen**

GSD does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use <https://globalsciencedirective.org> only with permission of a parent or guardian.

If you do not want information about you to be shared in this manner, do not use this feature.

### **International Users**

The Service is controlled, operated and administered by GSD from our offices within the USA. If you access the Service from a location outside the USA, you are responsible for compliance with all local laws. You agree that you will not use the GSD Content accessed through <https://globalsciencedirective.org> in any country or in any manner prohibited by any applicable laws, restrictions or regulations.

### **Indemnification**

### **Arbitration**

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

**Class Action Waiver**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and GSD agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
